The purpose of the march is to support community leaders who were arrested for intimidation.

Approximately 200 participants will take part and 30 marshals will be part of the event. Metro officers and Ekurhuleni EMS personnel are scheduled to monitor the event and help with free flow of traffic and to secure the safety of the procession and the community. 
