

(1)

The following information relates to the Zero hand grenade explosions on the East Rand.

(2)

Captain du Plooy, the head of the Detective Branch in Nigel under whose jurisdiction Duduza Township resorts, was interviewed. He referred the Investigator to Dunnottar SAPS, who is responsible for policing in the Duduza Township.

(3)

The inquest registers for deaths that occurred during the period June/July 1985 were perused personally by Investigator Kilian. No record of fatalities relating to hand grenades or explosions could be found in the registers. No inquest dockets relating to that period are still in existence.

(4)

Enquiries amongst policemen about possible victims also proved to be unsuccessful.

(5)

Kwa Thema police station was also visited and an inspection of the Archives by Investigator Kilian only revealed the name of one victim, viz Congress Mtsweni, who was killed in the apparent handling of a limpet mine. Kwa Thema inquest 150/1985 refers. According to Inspector "F" Du Plooy the relevant inquest docket has already been destroyed.

(6)

Investigations at Dunottar archives with the assistance of the Branch Commander Inspector A. Fourie revealed that no incidents of fatalities caused by explosions were registered over the relevant period.

(7)

Mrs Deysel, the Klerk of the Court at Nigel, was interviewed with an effort to trace any inquest dockets relating to the Zero hand grenades. She informed Investigator Kilian that the Investigating Team of the Attorney General, Pretoria, had already visited her in the same regard. She has no records of any hand grenade incidents in their judicial area.

(8)

According to her it was established that Captain Steenkamp, at the time attached to the Security Branch in Springs, mentioned in the Amnesty Application of J.H. Cronje was the investigator into the incidence of hand grenade explosions that occurred during the relevant period. He is also the same person mentioned as being present when the planning of the Zero hand grenades was planned with the past Commissioner of Police, General J.V. van der Merwe, who allegedly arranged the meeting.

(9)

A notice in terms of Act 34/1995 was served on Nelson Mtsweni, the brother of the late Congress Mtsweni who died in the limpet mine explosion on 26/6/1985 in Kwa Thema.

(10)

Congress Mtsweni was, at the time of his death, a final year student at Potchefstroom University and was an active member of COSAS.

(11)

Nelson was also requested to inform his mother, who was absent at the time of our visit, to gladly attend the hearings from 21/10/96 onwards.

(12)

The inquest registers at Brakpan SAPS were also perused to trace any particulars of people who were killed in hand grenade explosions over the relevant period. No registers or inquest dockets relating to the period June-July 1985 could be found. According to the Station Commissioner they have already been destroyed.

(13)

Investigator Kilian in a further effort to trace any of the victims of the Zero hand grenade explosions then visited the archives of the Magistrate Court in Brakpan, under whose jurisdiction Tsakane Township resorts. He personally perused all inquest files for the period 1984 to 1987, but could not find any trace of such incidents.

(14)

The telephone numbers of Steenkamp mentioned in paragraph 8 are (w) (011) 814-2351 and (h) (011) 814-6890. He was, however, not approached as it might later become necessary to subpoen him in terms of Section 29 of the Act.
