## ACCESS TO INFORMATION REQUEST

Your application for access to information dated 14 February 2013 herewith refers.

Upon perusal of your request for information in terms of section D of Form A, enquiries were made with the Chief Directorate: Air Quality Management in order to locate copies of historical Atmospheric Pollution Prevention Act (APPA) registration certificates and a copy of results of a 1992 study conducted by Sasol, at both their Sasolburg and Secunda facilities, and/or any atmospheric emission licences issued in terms of the National Environmental Management: Air Quality Act,

After making the necessary inquiries with the Gert Sibande and Fezile Dabi District Municipalities and reviewing the hardcopy APPA Registration Certificate database, I confirm that the Sasol Sasolburg facility has no registration certificate for incineration activities, I confirm that the Sasol Secunda facility has one registration certificate (RC 1972/20) which covers their incineration activities and a copy of this registration certificate is attached herewith.

The Department searched our records for the 1992 trial undertaken by Dr W.A. Schultheiss, but no record of this research was found, as such we are unable to provide you with the a copy of the requested study. Kindly find the attached affidavit in terms of Section 23 of PAIA in this regard.

Should you wish to appeal against the access fee to be paid or the form of access granted, you are referred to sections 74 and 75 of the Promotion of Access to Information Act, 2000 (Act No. 2 of 2000), which allows you to lodge an internal appeal together with the prescribed appeal fee, in the prescribed form to the Information Officer of the Department within 60 days. The subject and reasons for the internal appeal must be clearly indicated.
