- IV. Any instruction from the police must be adhered to
- V. Law breakers during the march will be arrested and prosecuted.
- VI. No alcohol use will be allowed

#### **b. Mbizana Municipality:**

Mr. L.W Joji gave the ff conditions:

1. Rumdel premises will not be entered and the marchers must stay in a demarcated area.
- II. No vulgar language, even in the form of pluck cards.
- III. Any misbehavior will be condemned
- IV. Time frame and route plan must be adhered to(during day time)
- V. Marshals must be in control of the crowd and will be identified by danger tape supplied by Mbizana Protection Services.

V1. Only one side of the road should be utilized and alternative road when situation are beyond our control.

V11. Indemnity letter must be supplied by

4. Gathering place and starting point will be at Bulala Sport Field.

. Gathering time 06h00 and starting time 09h00

. Handing over of petition 09h45

. Dispersing time from the Site will be immediately after response from Rumdell but provision is up until 11h00

5. Marchers will +-300 thus Marshalls will be 10% of the total number of participants.

6. Indemnity letter will be supplied by the conveners before starts.

7. Permission letter will be supplied by Mr Joji before the whole process.

On acquiescence of the indemnity letter.




### THE PROPOSED GATHERING ON 23 FEBRUARY 2016 HAS BEEN APPROVED.


