# 2. Acknowledgement of application letter.

The Chair acknowledged the letter of application from SADTU circulated it for confirmation and further explained the background in terms of the gathering Act of 1993.

#### **Conditions:**

## A. SAPS: (Captain Nongxeke)

- 1. Security and Protection is priority for SAPS.
- 2. Gathering should be quiet and peaceful march
- 3. No caring of weapons.
- 4. See if the gathering is according to standards.
- 5. Perpetrators will be apprehended.
- 6. No confrontation.
- 7. No Road Blocking
- 8. They must keep in demarcated area in front of entrance to the Department of Education.
- 9. Time frames should be adhered to.

## B. Mbizana Municipality: Protection Services

Mr. Joji gave the following conditions:

- 1. Traffic vehicle with blue lamps to lead the crowd and only one lane should be occupied.
- 2. No vulgar language, even on pluck cards.
- 3. Any misbehavior will be condemned



- 4. Marshals must be in control of the crowd and will be identified by danger tape supplied by Mbizana Protection Services (5% of the average number)
- 5. No confrontation
- 6. No Road Blocking
- 7. They must keep in demarcated area in front of Department of Education.
- 8. All participants to gather at Youth Centre.
- 9. March to strictly stick on time frames.
- 10. Indemnity letter should be supplied by the conveners to Protection Services.
- 11. Only fair plug cards will be allowed.
- 12. No weapons even traditional ones are allowed.
- 13. Marshals must work in hand with Police or vigilant to assist police.

# The following conditions were agreed upon:

- 1. Must be peaceful
- 2. No balaclavas or masks.
- 3. No vulgar language even in the form of pluck cards(we may have much control but we will be working together and assist each other)
- 4. Time frame and route plan must be adhered to
- 5. Marshals must be in control of the Crowd and will be identified by barrier tape supplied by the Mbizana Municipality Protection Services.
- 6. No weapons, even the traditional ones
- 7. Law breakers during the march will be arrested and prosecuted.
- 8. Gathering place and starting point will be at the Youth Centre
- 9. Indemnity letter must be supplied by the convener.
- 10. Any instruction from the police must be adhered to.
- 11. Any misbehavior or unlawful will be condemned
- 12. No alcohol use will be allowed
- 13. No confrontation to somebody who is part of the March.
- 14. No Road Blocking
- 15. Those who are doing unlawful things, police must do their work (Siswana)
- 16. Let us gather to the Entrance for Recipient and there will be no threating's (not exceeding 20m from the gate)
