RE: REQUEST FOR ACCESS TO RECORD OF PUBLIC BODY IN TERMS OF THE PROMOTION OF ACCESS TO INFORMATION ACT NO. 2 OF 2000 (PAIA)

We refer to the above matter and to your request for access to records of a public body received by us on 27 May 2014, the contents of which have been noted.

After careful consideration of your request for information, I wish to inform you that the department has identified two cases only namely: Mr Mathew Blackman vs. Minister of Arts and Culture and two others.

In the matter between Mr Blackman vs. Minister of Arts and Culture the department was represented by Magaga Inc Attorneys and two Counsels, the total amount paid by the department to Magaga Inc Attorneys is R82 449.95. The sums of R25 650.00 and the R11 000.00 were disbursement paid to the Senior and Junior Counsels respectively.

The department paid an amount of R17 531 .36 to the applicant's attorneys being taxed costs. Please find the information enclosed in **Annexure A** hereto.



With regards to information relating to SAHA Trust matter, I wish to advise that the department was represented by the office of the State attorneys, Pretoria and the total amount paid by the department is R28 853.49 to the applicant's attorneys.

The sums of R 25 716.80 and R3 136.69 were taxed costs paid to the applicant's instructing set of attorneys and to their second set of attorneys respectively. Please find the information enclosed in **Annexure B** hereto.

Please be advised that there are no internal costs incurred by in-house lawyers or officers responsible for PAIA requests in the department and matters are handled as and when they arise.

You are advised that if you are dissatisfied with the above you may lodge an internal appeal against my decision with the Minister within 60 days of my decision.

In the case you are dissatisfied with the outcome of the appeal, you may lodge an application with a court having jurisdiction in this matter to review the decision.
