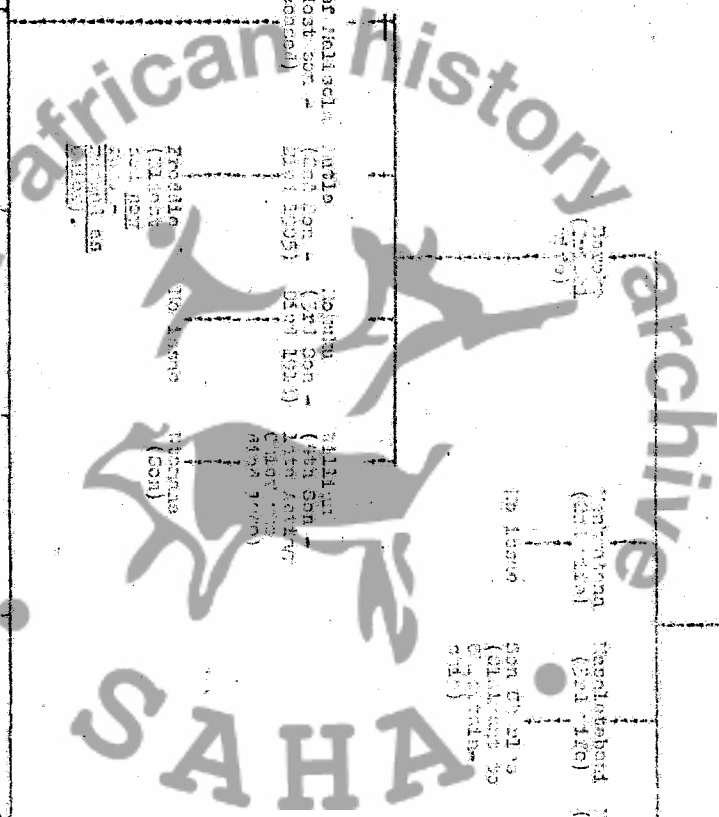
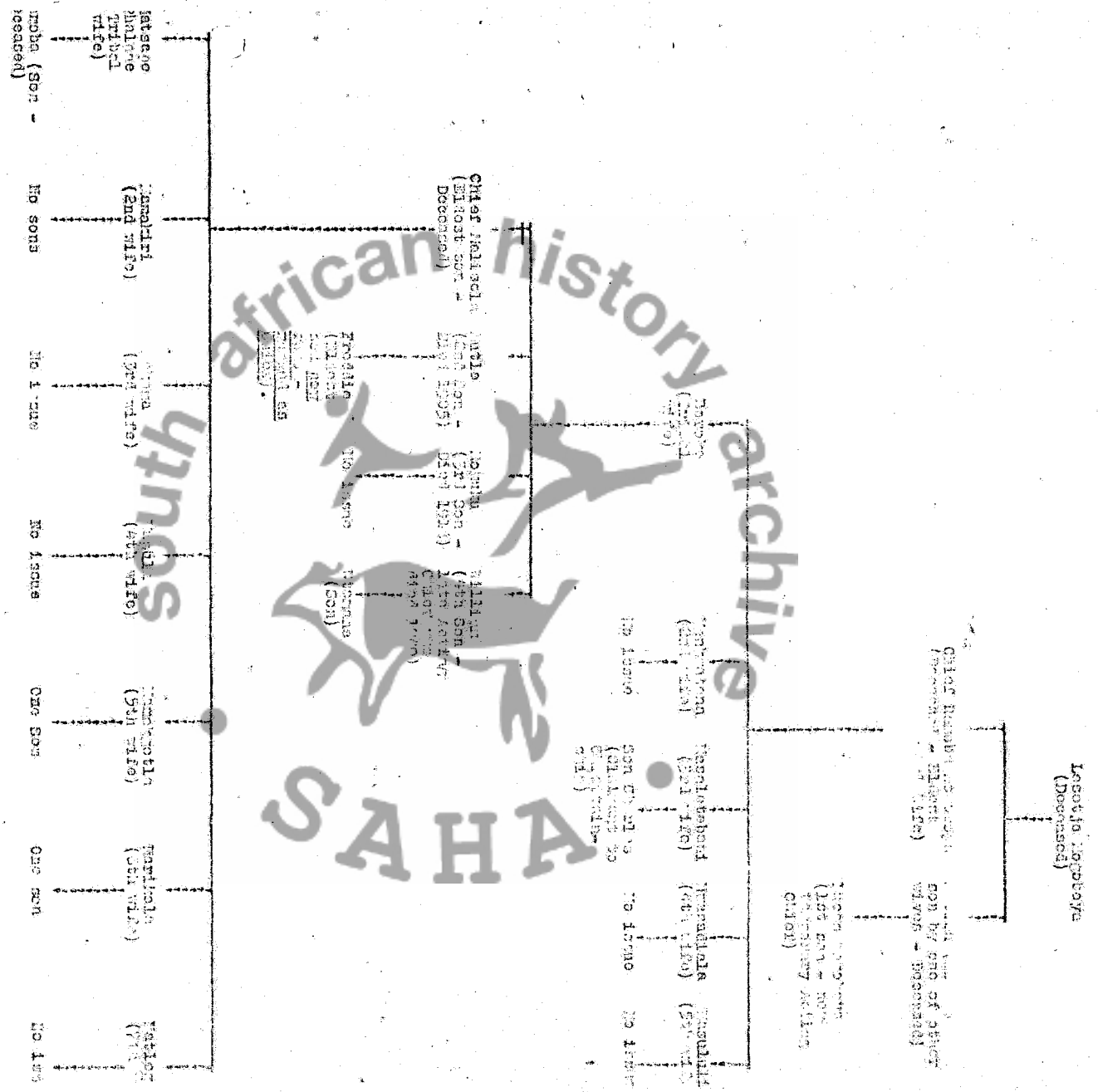

IT IS HEREBY certified that His Excellency the Governor-General has been pleased to approve under the powers vested in him by section 112 of the Native Administration Act, 1927 (Act No. 38 of 1927), as amended, of the appointment of -

FREDDIE MOGBOYA

as Chief of the Bapadi-ba-Thabana tribe resident in Mogoboya's Location and on portion of the farm Craighoad No. 408, in the Tsaneen area of the district of Letaba, with effect from the 8th July, 1950.

THE HONOURABLE the Minister of Native Affairs has, furthermore, approved in terms of sections 112 and 112A of the Native Administration Act, 1927, of the conferment on the abovementioned FREDDIE MOGBOYA of civil and criminal jurisdiction.

Signed at PRETORIA this 13th day of July 1950.
