2	<u>CHAIRPERSON</u> : The parties, if they wish
3	to show us things at the places we are, must please do so.
4	When someone speaks, he or she must please give his or her
5	name for the transcribers, and also please check with the
6	contractors who are here that you're close enough to the
7	microphone so what you're saying will be audibly recorded.
8	If when we're finished, or as we go along, if there's a
9	place which any party thinks is important which we're not
10	being taken to but we're walking in the vicinity of, please
11	say so, so that we can then go to that place as well. So
12	you all understand. Thank you. Mr -
13	MR WESLEY: Judge, I think the easiest,
14	we can go across the field, or we can stick to the road. I
15	have no preference.

17	what's your preference.
18	MR WESLEY: Let us stick to the road to

3	Hostel at the spot near the railway line where General
4	Mpembe addressed a group of strikers who were coming back
5	from the Karee Mine.
6	MR WESLEY: Right, thank you. I've asked
7	General Mpembe to indicate the spots where he stood and
8	where the crowd was in relation to where we're standing
9	now. If he could, it's more or less to the south here. If
10	the people could just part here to the south, just open up
11	a passage on the road.
12	MR MPOFU: I also have one or two of the
13	people who were in the march -
14	<u>CHAIRPERSON</u> : Would it be helpful to get
15	our bearings, because it's overcast, we can't see the sun
16	properly. Show us where south is, north is, west is, and
17	east.
18	MR WESLEY: South is approximately that
19	way.
20	<u>CHAIRPERSON</u> : On the other side of the
21	rail, on the Karee side of the railway line?
22	MR WESLEY: The other side of the railway
23	line, Karee side. North then of course is on the opposite
24	side. East -
25	<u>CHAIRPERSON</u> : That's west. That's west.
