

1. *The Respondents are directed to adhere fully to the UJ student regulations regarding organised student protest activities as set out in Regulation 6 thereof;*
2. *the Respondents are to limit all protest activities to the designated areas as set out in Annexure "A.1 to A.4" hereto;*
3. *the Respondents are interdicted from:*
 - 3.1 *Disrupting or in any way interfering with normal activities such as participating in SRC elections, examinations and graduation ceremonies;*
 - 3.2 *Barricading any entrances and streets;*
 - 3.3 *Damaging or vandalising any UJ property;*
 - 3.4 *Intimidating or harassing students or staff of UJ.*
4. *Directing that the Sheriff of the High Court enforce the interdict as set out in paragraphs 3.1 to 3.4 above within two hours of service of this order;*




