#### COMPLAINT AGAINST SAPS: COMPLAINANT MR PARKER

- 1. Your e-mail correspondence (dated 23<sup>rd</sup> July 2014, 12:10) pertaining the concerns raised by Mr Parker (hereinafter referred to as the complainant), refers.
- 2. The concern was diverted to Riebeeck West SAPS for investigation in terms of SO (G) 101.
- 3. The following concerns was raised:
  - ♣ The complainant alleged that the police, in specific Warrant Officer Adonis did not act on an alleged early warning with regards to a mob attack on his business. The police was provided with the information by his daughter.
  - Lt is further alleged that the suspects in Riebeeck West CAS 145/11/2012, MITP, Arson and Intimidation, were summoned to court, without being arrested or placed in the cells.
- 4. The complainant was interviewed on 17<sup>th</sup> September 2014 and statement obtained by the Station Commander.
- 5. Warrant Officer Adonis was interviewed and he stated that he never met or spoke to the complainant or any family members.
- 6. During the interview with the complainant's daughter she confirmed that she never contacted the police.
- 7. The prosecutor, Ms Bloemfontein expressed her satisfaction with the investigation which D/Sergeant Cloete conducted. D/Sergeant Cloete acted on the instruction of the prosecutor to summons the suspects to court.
- 8. Feedback was provided to the complainant on 10<sup>th</sup> October 2014 by Captain Gerber, but is still not satisfied as he does not believe the outcome of the investigation.
- 9. The complainant will not be satisfied and believe in his own opinion.
