

ON THE PURPOSE AND FUNCTIONING OF A JOC


- Joint Operational Centres (JOC) are established in advance on national, departmental, regional and district levels and form the basis of an integrated hierarchical security management system for the IEC



- Within the JOC on each level areas for joint operations are identified, planned and execution co-ordinated and monitored. This is done in a spirit of mutual support and understanding of each other's line function and specialist field

- The site of a JOC is determined by aspects such as availability of accommodation/logistics/communication; security considerations; and proximity to area of influence
- Only bona fide members of a JOC will have access thereto - not open to general public
- When appointing personnel to a JOC due regard to be had to experience, seniority, qualifications.
- JOC's will function on a 24h basis and in terms of Standing Operational Procedures.


