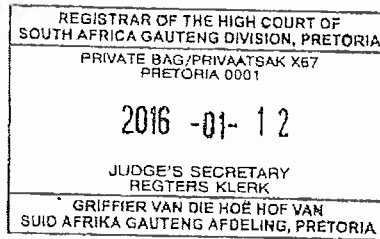

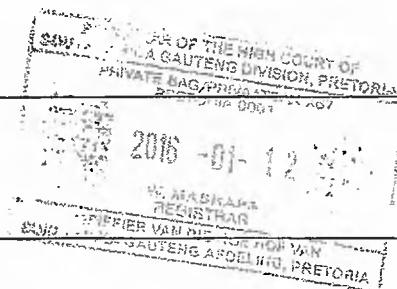

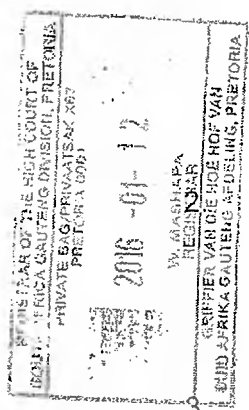

ORDER



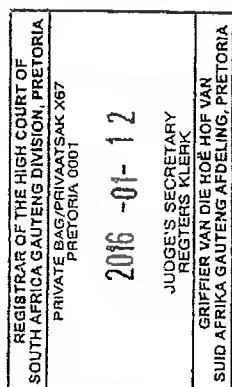
Having heard Counsel and having read the papers it is ordered:

1. An order is issued dispensing with the forms, service and time periods prescribed in terms of the Uniform Rules of Court, and directing that the matter be heard as one of urgency in terms of Rule 6(12) of the Uniform Rules of Court; is ordered that



An order is issued dispensing with the citation requirements in rule 6(2) in respect of the first and tenth respondents

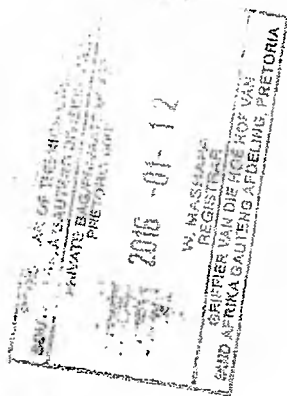
The respondents are directed to show cause on 9 February 2016 at 10h00 , or as soon thereafter as counsel may be heard, why an order in the following terms should not be made final:



- 3.1 An order directing all persons unlawfully occupying the Client Services Centre of the University of Pretoria to immediately desist from further unlawfully occupying the Client Services Centre and/or disrupting the operations of the Client Services Centre;
- 3.2 An order restraining all persons participating in protest action at the campuses of the University of Pretoria, related to outsourcing and labour broking, from disrupting the normal operations of the University of Pretoria in any manner, including disruption of services offered by the Client Services

Centre and/or occupying any facilities, offices or residences of the University of Pretoria;

3.3 An order interdicting and restraining the respondents, including their supporters and/or members from directly or indirectly:



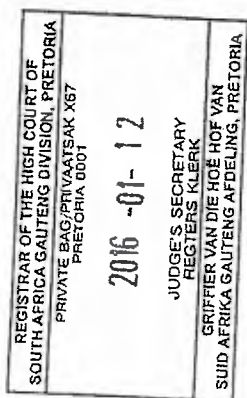
3.3.1 Taking part in or instigating disruptive or riotous behaviour that may result in damage to any property of the University of Pretoria or the infringement of the rights of any staff member, student and/or visitor to the universities' premises;

3.3.2 Obstructing or preventing ingress or egress of students, staff or visitors to the campuses of the University of Pretoria;

3.3.3 Infringing traffic rules or obstructing the flow of traffic on the applicant's premises and adjacent public roads;

3.3.4 Disrupting or otherwise interfering in any way with the normal activities of the University of Pretoria at any of its campuses, including but not limited to the following:

3.3.5 Registration of students;



3.3.6 Summer schools offered to students of the University of Pretoria;

3.3.7 the Welcome Day for new students and their parents scheduled for Saturday, 16 January 2016;

3.3.8 The administration of the University;

3.3.9 Chancellor's examinations;

3.3.10 Interdicting and restraining the respondents, and where applicable, their supporters and/or members and/or followers from participating in, calling for, supporting, encouraging or inciting unlawful behaviour, violence, causing damage to property and from intimidating, threatening, harassing or harming:

3.3.10.1 Any employees of the applicant;

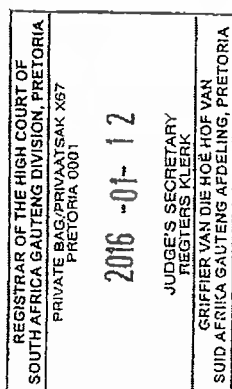
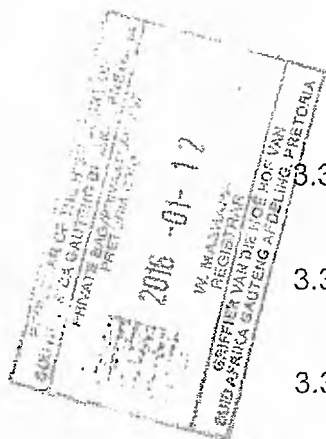
3.3.10.2 Any students of the applicant;

3.3.10.3 Any contract workers ;

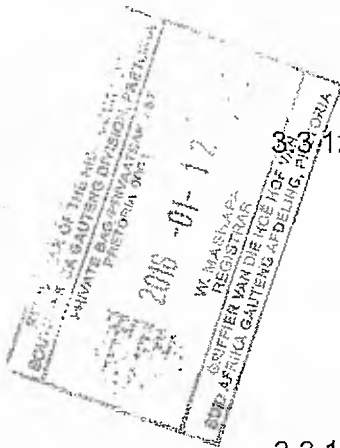
3.3.10.4 Any service providers of the applicant;

3.3.10.5 Any other person present on the applicant's campuses;

3.3.11 Restraining the respondents and where applicable, their supporters and/or members and/or followers

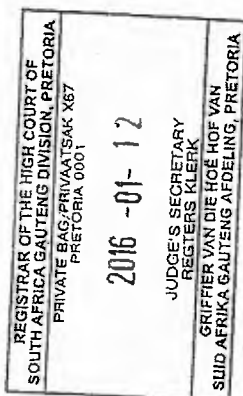


from carrying firearms or dangerous weapons defined in the Dangerous Weapons Act, 15 of 2013, or knives or other sharp objects, sticks of any kind at, or near the entrance to any of the campuses of the applicant or on any campus of the applicant;



3.3.12 Restraining the respondents, and where applicable, their supporters and/or members and/or followers from vandalising property or illegally occupying any buildings on the campuses of the applicant;

3.3.13 Directing the leadership structures of the EFF Student Command to take all reasonable and necessary steps to ensure compliance with this Court Order by its members and/or followers, by *inter alia*:



3.3.13.1 Communicating by social media the contents of this Court Order; and

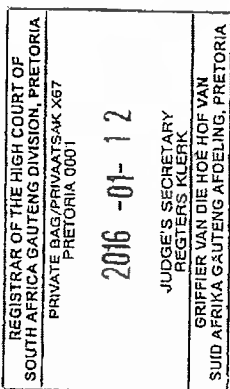
3.3.13.2 Requesting its members and followers to conduct themselves lawfully, to refrain from intimidation, acts of violence and damage to the applicant or any other public property;

3.4 Should the leadership structures of the EFF Student Command fail to ensure compliance with this Order, they are

called upon to advance reasons why they should not be held in contempt of Court;



3.5 Should the respondents and their members or followers fail to comply with the terms of this Order or any part thereof, the SAPS and/or Public Order Policing Unit are directed to take steps or measures necessary to ensure compliance with this Order and to maintain law and order at the University's premises;



3.6 Should the respondents and/or their members of followers fail to comply with the terms of this Order or any part thereof, the SAPS and/or the Public Order Policing Unit are authorised to enter upon any premises of the University of Pretoria in order to ensure compliance with this Court Order.

4. Any respondent can anticipate the return date on 72 hours written notice.

5. Service of this Order shall be effected in the following manner:

5.1 By service by the Sheriff on the respondents by loud hailer at the entrance or entrances to campuses or premises affected by student protest action;

5.2 By posting this Court Order on the official website of the University of Pretoria;

- 5.3 By posting a copy of this Court Order at all entrances to campuses of the University.
6. The costs of the application are reserved for determination on the return date.
