DRAFT ORDER

1. A rule *nisi* is issued in terms of which the respondents are called upon to show cause on the return date, 13/08 2014, why an order in the following terms should not be made a final order of the above honourable court :

1.1 That the respondents are interdicted from committing any act which is prejudicial to the good name, administration, discipline or efficiency of the applicant or acting in any way which is detrimental to the name or normal functioning of the applicant;

1.2 That the respondents are interdicted from assaulting, molesting, harassing and/or intimidating staff members and students of the applicant and visitors to the Medunsa campus of the applicant.

- 1.3 That the respondents are interdicted from erecting barricades and/or blockades at the entrance to the aforementioned campus;
- 1.4 That the respondents are interdicted from disrupting any functions of the applicant or its officials, including academic programmes, lectures, practicals, clinical sessions, tutorials, tasks, class tests and examinations at the aforementioned campus;
- 1.5 That the respondents are interdicted from damaging, destroying, abusing, alienating or appropriating any property and/or asset of the applicant and its officials, staff members, students and/or visitors anywhere, including on the aforementioned campus;
- 1.6 That the respondents are interdicted from infringing the traffic rules of the applicant on the aforementioned campus;
- 1.7 That the respondent are interdicting from infringing any of the rules of the applicant;


- 1.8 That the respondents are interdicted from infringing any of the rules of residences, including catering and accommodation services, under the control of the university;
- 1.9 That the respondents are interdicted from taking part in or instigating disruptive or riotous behaviour resulting in damage to property of the applicant or the infringement of the rights of any staff members, students and/or visitors of the applicant;
- 1.10 That the respondents are interdicted from intimidating or performing any act or acts with the intent to cause bodily harm to any of the staff members, students and/or visitors of the applicant or acts of violence or assault;
- 1.11 That the respondents, as well as members or officials of the SRC of the applicant at the Medunsa campus and the other individual respondents, are interdicted from inciting students of the university to participate in disruptive activities at the aforementioned campus;
- 1.12 That the respondents are ordered to pay the costs of the applicant, the one paying the other to be absolved to the extent of the payment.

2. Prayers 1.1 to 1.11 shall serve as an interim interdict against the respondents until the return date.

3. Service of the court order :
 - 3.1 By delivering a copy of the order to the offices of SRC at the Medunsa campus of the university and/or faxing a copy to the office of the Vice-Chancellor or Executive Director of Marketing of the University of Limpopo for delivery by a security of official; and/or
 - 3.2 By displaying a copy of the court order at all entrances and/or notice boards of the applicant at the Medunsa campus.
