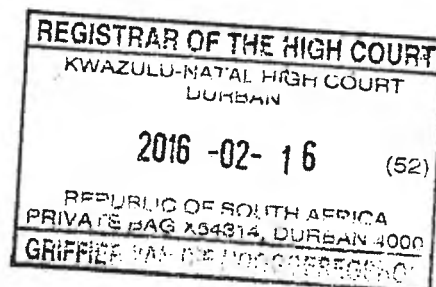

UPON the Motion of Counsel for the Applicant and upon reading the *NOTICE OF MOTION* and the other documents filed of record

IT IS ORDERED

1. That a Rule Nisi do hereby issue calling on the Respondents to show cause, if any, on the 23 day of FEBRUARY 2016 at 9:30 am or so soon thereafter as counsel may be heard why the following orders should not be made final:-

- (a) that the Respondents, in relation to the Applicant's premises located at Westville Campus, Westville, Howard College, Durban, Edgewood Campus, Pinetown, Nelson R Mandela School of Medicine, Durban and Pietermaritzburg Campus, Pietermaritzburg ("the Applicant's premises") be and are hereby interdicted and restrained from:-
- (i) barricading, restricting or in any way interfering with the entrances or access points to the applicant's premises;
 - (ii) preventing, restricting or in any way interfering with the access to and egress from the Applicant's premises by any person or vehicle;
 - (iii) damaging or removing any of the Applicant's immovable and movable property located at the Applicant's premises;
 - (iv) assaulting, intimidating, harming or harassing in any way any person attempting to work at the Applicant's premises and/or any person gaining access to the Applicant's premises and/or leaving the Applicant's premises;
 - (v) inciting, encouraging, organizing, participating and co-ordinating any unlawful gathering, demonstration or mass action or any other unlawful conduct at or on the Applicant's premises;
2. That any respondent opposing the application be directed to pay the cost of the application on an attorney and client scale.
 3. That the relief set out in paragraph 1(a) above operate with immediate effect as an interim interdict pending the final determination of the application.
 4. That service of the Order and application papers upon the Respondents be effected as follows:
 - 4.1 By Sheriff of the High Court making copies of the application papers and the order available for inspection in common areas on each of the Applicant's Campuses, including notice boards and cafeterias;
 - 4.2 That the Applicant cause service of the papers and court order on the eighth Respondent by way of email and facsimile;
 - 4.3 By the Sheriff of the High Court placing a copy of the application papers and court order on the main gates of each of the Applicant's Campuses;
